Please be advised that the amount of **SEVEN MILLION TWO HUNDRED NINETY THREE THOUSAND PESOS ONLY (P7,293,000)** was released through the Bureau of the Treasury (BTr), details as follows:

SARO No. : SARO-BMB-C-16-0034458
Funding Source : Republic Act No. 10717 (FY 2016 General Appropriations Act)
Purpose : To cover the release of national government subsidy for operations for the 4th quarter to PCED, (P3,293,000) and for the rehabilitation of PCED building, (P4,000,000).

Likewise issued is NCA No. NCA-BMB-C-16-0023279 in the same amount, to cover the cash requirements of the above-mentioned allotment.

Accordingly, said NCA will be transmitted to the Land Bank of the Philippines – Intramuros, Manila Branch for credit to the BTr's MDS Sub-Account No. 2001-90167-3, which, in turn, will transfer the fund to the PCED.

The attached Monthly Requirement Schedule for NCAs (MRS-NCA) presents the details on the funding source as well as the specific period for the bank to credit the programmed amounts to the specified MDS sub-accounts.

We highly encourage GOCCs, including PCED, that receive budgetary support from the National Government – either as subsidy for operational expenses and projects or equity for projects – to utilize the funds released to them through the BTr, as conduit, following the validity of the appropriations stated in the General Appropriations Act.

Moreover, the validity of the NCA shall be in accordance with the provisions of Section 5.4 of National Budget Circular No. 561 dated January 4, 2016.

Further, actual utilization/disbursements out of the cash allocation shall be subject to the existing budgeting, accounting and auditing rules and regulations.
